Food Insecurity



Because of the pandemic and job loss, perhaps you, or someone you know, is experiencing food

insecurity. If so, please consider the following resources:

• **Food Pantries:** Use the link below to locate a food pantry of your choice by placing your neighborhood or zip code in the search engine at: www.gbfb.org/need-food. Please call the food pantry first to confirm that the food pantry is open.

• **SNAP/Food Stamps:** The **Greater Boston Food Bank (GBFB)** can help neighbors apply for SNAP/Food Stamp benefits.

Neighbors should contact **GBFB** to find out if they are eligible, to apply, or for support on their existing case. Call **617-598-5022** or visit gbfb.org/SNAP.

Please Note: During this pandemic, all households who would normally qualify for the minimum monthly SNAP benefit (\$19 per two person household) would actually receive the maximum monthly SNAP benefit (\$430 per two person household.)
